Program Year 2020 - A Look Back....

Looking back, PY'20 was the year of the COVID Roller Coaster Ride. In March, 2020, then Governor Cuomo issued a NY Pause order, and all of our Workforce Career Centers closed their doors. Our WIOA staff pivoted to working remotely, providing essential services such as Business and

Employer Services, Workforce Advising, Metrix Learning, Partner Sharing, and Youth services.

In June 2020, staff returned to our Centers on Monday, Wednesday and Friday, providing in–person services on an appointment-only basis, and remote services Monday through Friday.

But the Roller Coaster ride was destined to continue. In December 2020, with an uptick in the COVID cases, we closed our Centers and returned to providing all services remotely. We brought staff back to the Centers in late February 2021 and again opened our doors to customers Monday, Wednesday, and Friday while continuing to provide services remotely Monday through Friday. In May, we opened our doors to customers 5 days a week, initially by appointment only, while continuing to provide services remotely to those customers who preferred that method of service delivery.

Back in the office, staff, who had been in contact by Zoom every day, enjoyed the renewed collegiality of stopping by another staff person's desk just to say "hello" or compare notes on a customer or service. And while many customers found that they did very well with virtual services, others preferred the return to face-to-face contact.

Over the last year, we have learned great things about the flexibility and creativity of hybrid services and the people who provide them, reinforcing what we've always known about our staff – smart, quality, caring people.

I am retiring on October 1 after 21 years as Executive Director of the FMS WDB. I wish our incoming Executive Director Regina Papa, Board staff Beverly and Kim, and FMS WDB Chairwoman Pamela Goldswer and Board Members, and Partners all the best. I will miss you all!

This year saw many of us move from improvising through the unknown to developing and evolving ourselves. Whether we were working from home this year, following safety in the office, or working through a hybrid model, we've all gained experience in managing change.
